Policy/Procedure Statement

The determination and dissemination of the HEERF II CRRSAA Grant will be the responsibility of the Business Office and Financial Aid Department. Below is an outline of how this process should be handled by the Business Office and Financial Aid Representative for all eligible Title IV students.

Reason for Policy

To ensure that students from our institution who need financial support for their expenses related to the disruption of campus operations due to Coronavirus, receive grant funds from the HEERF II Grant.

Who Should Read This Policy

Financial Aid, Business Office, Compliance

The Policy/Procedure

Only students who are receiving Title IV with Bellus Academy may receive funds from the HEERF II grant. Any students not using Title IV with Bellus Academy are not eligible for grant funds due to the potential risk of them receiving multiple HEERF II grants. **Change effective 09/01/2021 – Students that did not use Title IV may also be eligible.**

Student eligibility requirements must be met in order to be eligible for the grant. Requirements are that a student complete the FAFSA application for 2020/2021 and 2021/2022, resolved all C codes, and completed verification if selected by ED or by the school. **Change effective 09/01/2021 – Students that did not use Title IV may also be eligible.**

Students in a Currently Attending and Leave of Absence status as of April 27th will be included in the 1st awarding of funds.

All Policies are Subject to Amendment

Students that have been withdrawn or graduated from Bellus Academy as of April 27th will not be eligible for grant funds.

There will be consideration of Professional Judgment based on circumstances for students that may have a change in EFC.

Students will receive the HEERF II grant eligibility amount in one payment. Award amount will be determined based on greatest need. Students 2020/2021 and 2021/2022 EFC will be used to determine the range in which the student is eligible.

EFC tiers are as follow:

Tier 1: EFC Range 0-2900 Tier 2: EFC Range 2901-5711 Tier 3: EFC Range 5712-999999 Maximum and minimum amounts vary per campus Change effective 09/01/2021 – Students that did not use Title IV will receive a flat amount.

Eligible students will be sent an award letter outlining how the school determined their eligibility, how much they are eligible for and how funds should be used. This will not require a signature from the student in order to release funds. A copy will be placed in the Financial Aid office.

Students that do not cash their checks within 90 days, will be contacted directly to ensure address is correct. Any grant funds that are declined by the student will be reissued to another eligible student.

Business Office Responsibilities:

- 1. Disburse eligibility check to students
- 2. Track checks issued to students
- 3. Determine uncashed checks at 30 days for possible reissue

Financial Aid Responsibilities:

- 1. Determine Title IV eligible students
- 2. Determine students eligible for HEERF II grant funds
- 3. Disseminate award letters to eligible students by email
